

2014 Farm Bill: state pilot programs


2018 Farm Bill: 0.3% D9 THC legal

- Legalizes derivatives, including CBD
- Removes hemp from Schedule One of CSA

Minnesota hemp statute mirrors 2018 Farm Bill

### **Summer 2022: Edible Cannabinoid Products**

Legalizes hempderived THC in food/beverages 5mg per serving, 50mg per package

 MN Statute §151.72, Subd. 5a(f) Effectively legalized intoxicating cannabis products for adults.

No vapes, no topicals with more than 0.3% THC

Adult use (21+)

"Certified Hemp," COAs

No license required. (!?!)

No special tax. (!?!)

Board of Pharmacy regulates. (!?!)

Moratoriums ensue

No sales in liquor stores.





### 2023: Hemp-Derived THC Products Post-Legalization

"Low Potency Hemp Edibles"

Beverages limited to two servings per package (i.e., 10 mg)

Sales in liquor stores now legal

Can continue to be sold without license until March 2025

Must register with MN Department of Health by 10.1.23

Manufacturer and retailer licenses available (estimated date of issuance = 2025)

## What Will Happen to Hemp-Derived THC Products?

- Adult-use MJ and hemp-derived
  THC
- Onboarding adult-use takes time
- Until late 2024 (early 2025), the hemp-derived product market will continue to flourish.

#### Hemp vs. marijuana

- Interstate commerce
- No tax penalty
